

Guidelines for the academic papers for National Conference on Law, Economics & Technology 2018

1. The topics for the academic papers are as follows:

1.1. Law & Economics in antitrust and competitive markets

1.2. The Science & Economics of Intellectual Property Law

1.3. The Economics, Law & Practice of Real Estate in India

1.4. The Law & Practice of Insolvency & Bankruptcy after the 2018 Ordinance

1.5. The way forward for Domestic and International Commercial Arbitration

1.6. The legal standing of technologies such as Blockchain & Artificial Intelligence

1.7. The use of emerging technologies to rationalize the legal system and reduce pendency

2. The above stated themes in Section 1, are encouraged, while papers from allied fields of law, economics and technology may be accepted after the approval of the Editorial Board. The relevant guidelines regarding the papers are as follows:

2.1 All papers should be between 3000 and 5000 words and must conform to the Harvard Bluebook 19th Edition of Citation Methodology.

2.2 Papers only in the form of Case Comments, Research Papers and Essays will be accepted.

2.3 All papers must include an abstract page, not exceeding 400 words, covering the research question, methodology employed and findings or conclusion.

2.4 The Title of the Paper shall be in Times New Roman, Bold, Size 16 and Center-Aligned

2.5 The Section Headings of the Paper shall be in Times New Roman, Bold, Size 12

2.6 The footnotes shall be in Times New Roman, Size 10

2.7 All other content shall be in Times New Roman, Size 12 and 'Justified' Alignment with a line spacing of 1.5. The paper shall have a double-lined border and shall have page numbers at the bottom of the page.

2.8 Up to two co-authors per papers are permitted. Academicians, students, researchers, lawyers and other experts from within the legal community may send in their papers.

2.9 Final Drafts are to be sent to law.economics.technology@gmail.com by 11:59 pm on 10th November 2018. Any submissions after the given date will be subject to the approval of the Editorial Board for their acceptance.

2.10 All draft papers must include the following details on the abstract page:

- a. Name(s) of Author(s)
- b. Email Address & Postal Address
- c. Mobile Phone Number
- d. Name of Institution & Year of Study
- e. Address of Institution
- f. Title of the Paper
- g. Abstract (with research question, methodology and findings)

2.10. Papers will be reviewed by one or more members of the editorial board to be compiled into a journal for publication on 17th November 2018. Authors may also choose to present their papers at the conference on 16th or 17th November 2018.
